NOTICE TO SURFACE MINING AND RECLAMATION OPERATORS

Digital Submissions of Surface Mining Applications & Permit Actions

The Surface Mining and Reclamation Division of the Railroad Commission of Texas (RRC) requests that all application materials and permitting actions be submitted in a digital format in lieu of paper hard copies. The protocol for submitting these materials is outlined below, along with a checklist of file-type and formats that will help expedite processing and distribution of materials.

- ✓ Official submission of a permit action shall be a 'searchable' PDF.
- ✓ Submit one email per project notice to <u>SMRD_Mail@rrc.texas.gov</u>.
- ✓ If documents are too large to be submitted though email, they can be submitted through BOX mail, however the cover letter for the project must be receive by SMRD_Mail with a notation in the body of the SMRD_Mail stating BOX mail has been submitted for this project.
- ✓ A Docket Number or File Reference Number should be included in the cover letter RE: (subject line), if one has been assigned.
- Subject line of the email notice should be the mine name, permit number and short/minimal description (The email submittal could be declined if the subject line does not match the project attached).
- ✓ Each attached document should have a file name.
- ✓ Submittals will be stamped in on the day they are received before close of business (COB), 5 p.m. Submittals received after COB will be stamped the next business day.
- ✓ A notification of receipt of submission will be sent when the application is processed and filed within the Surface Mining and Reclamation Division records.

Digital submittals should **NOT** include:

- 1. McAfee security files
- 2. Docket number or financial info within the email subject line

Georeferenced AutoCAD/GIS shapefiles should be submitted as working files for any exhibit, plat, or figure.

Microsoft Excel files, with formulas, should be submitted as working files for the following permit actions:

- 1. Post-mine soil reports
- 2. Soil maintenance / soil fertility/ soil augmentation reports
- 3. Random 10% resampling reports
- 4. Vegetation reports
- 5. Groundcover productivity reports

- 6. Groundwater and stem count reports
- 7. Bond calculations

Microsoft Excel, or CSV, files should be submitted as working files for the following permit actions:

- 1. Wildlife sightings
- 2. Hydrological data
- 3. Well completion information

Additional working files should be submitted in the following format:

- 1. Audio files (from wildlife surveys)
- 2. HEC-RAS
- 3. Sed-CAD
