What incidents to we investigate?



- All reportable incidents
- Reporting-regulated only
- Verification
 - Courtesy calls
 - Retracted incidents
 - Interstate

Inspector's Responsibility



- Review operator's actions, procedures, and records to determine compliance with code and adherence to operator's procedures
- Includes Emergency Response Plan

Stakeholders



- Operator
- Accident Coordinator
- Inspector
- State Accident Lead
- PHMSA Program Director
- Executive Leadership (O&S, Exec Director, Commissioners, Communications, Media relations)
- PHMSA, NTSB, Others

Commission Actions (1 of 3)



- Receives call / contacts on-site personnel
- Gathers information from operator / site
- Determines Go / No-Go
- Schedule 30-Day review meeting / procedures /
 Records / operator's accident investigation
- Work on Incident Checklist
- Follow up meetings

Commission Actions (2 of 3)



- More follow up meetings
- Submit Inspection Package (IP)-send exec closing
- Reviewed by State Accident Lead
- IP sent back to Inspector
- Follow up meeting(s)
- IP resubmitted-Executive Closing Sent
- State Accident Lead reviews, submits

Commission Actions (3 of 3)



- PHMSA Program Director Reviews IP
- Sends back to Inspector
- Follow up meeting(s)
- Inspector submits IP-Executive Closing sent
- Oversight and Safety Director review

Retractions



- Information needed
- Operator Name and OPID
- NRC Report Number (if applicable)
- Date / Location of Incident
- Justification of Retraction
- Letter of Retraction on Letterhead in PDF

Retraction for Distribution



Information needed, but not limited to:

- Pressure Test
- Bar-Hole / Leak Survey Test
 -with line locate accuracy
- Chromatograph
